



# 2016: 3-Tiers To A Fantastic Year!

In 2016, San Diego Coastkeeper scored major clean water wins by harnessing the powers of community education, data-driven advocacy, and legal action--the foundation of our work. Our newly devised water science curriculum introduced pollution prevention to San Diego's littlest advocates, and the strategic deployment of our industrial stormwater campaign means major polluters will be held accountable for their roles in poisoning our waters. It has been a good year, indeed. Thank you to our volunteers, funders and supporters: you are the keys to unlocking clean water in San Diego County.



We collaborated with 158 Water Quality Monitors and trained 67 first-time volunteers. This group of clean water activists collectively gave 1,913 hours of their time.

Our 6,333 community volunteers removed an incredible 9,399 pounds of trash from beaches across San Diego County.



We initiated five enforcement cases to stop stormwater polluters and protect our waters.

We excited 7,932 students, teachers, and community members about protecting and restoring clean water through our standard-aligned, hands-on water education curriculum.



With our strong input, the Regional Water Quality Control Board approved eight plans that require positive water quality outcomes.

Saw years of work come to fruition when the San Diego City Council passed a city-wide, single-use bag reduction ordinance, which was followed by a statewide ban.
